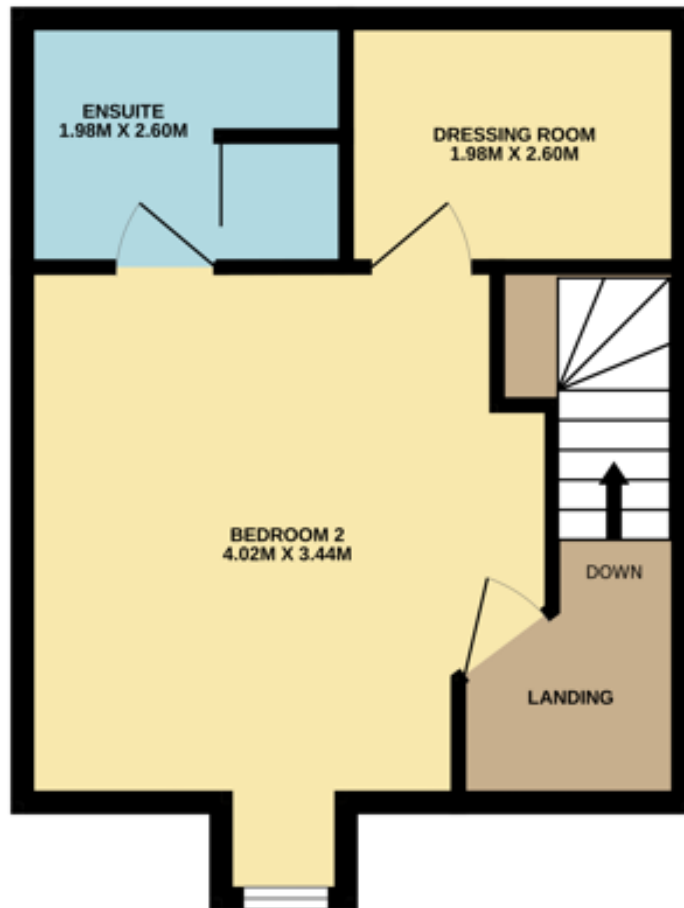
GROUND FLOOR
